Revised Submitter Onboarding Strategy

Previous	Updated
Initial pilot with small number of payers	Sample data only
Three waves of payers over 2+ years	Two waves – Medical/Pharmacy and Dental Under 18 months, including extensions
All Medicare in last wave	Medicare FFS in 2024 Medicare Advantage in 2023
Completion in June 2025	Completion in December 2024

Submitter Rules and Data Submission Guide

The submitter rules and data submission guide establish the format, standards, procedures, and deadlines by which health and dental plans must submit data files to the Georgia All-Payer Claims Database.

- Input from Data Submission Standards (DSS) subgroup Summer/Fall 2022
- Proposed rules published for public comment on 12/21/2022
- Intent to adopt published on 2/1/2023
- Rules become effective on 3/3/2023



APCD Published Rules

Topic	Rule
Covered lives baseline	Covered lives as of 12/31 of the previous year.
Covered lives threshold	1,000 covered lives
Population	All claims for Georgia residents and their dependents, regardless of where the service was delivered.
Submission frequency	<ul style="list-style-type: none">• Monthly submission• All claims adjudicated during the reporting period.
Submission sequencing	No phased onboarding within payer types but provide a path for extensions.
Penalties	\$1,000 per day
Registration deadline	Registration by no later than March 7, 2023
Health & Pharmacy Data	Due June 1, 2023
Dental Data	Due December 1, 2023



Changes incorporated as a result of comments

- Clarification that stand alone vision claims for non-medical services will not be required at this time
- Clarification that the 1,000 covered lives threshold includes 1,000 covered lives in aggregate across all plans
- Added a definition of “Georgia resident” as any eligible member whose residence is within the State of Georgia, and all covered dependents

- 14 are currently working with Onpoint to finalize their registration

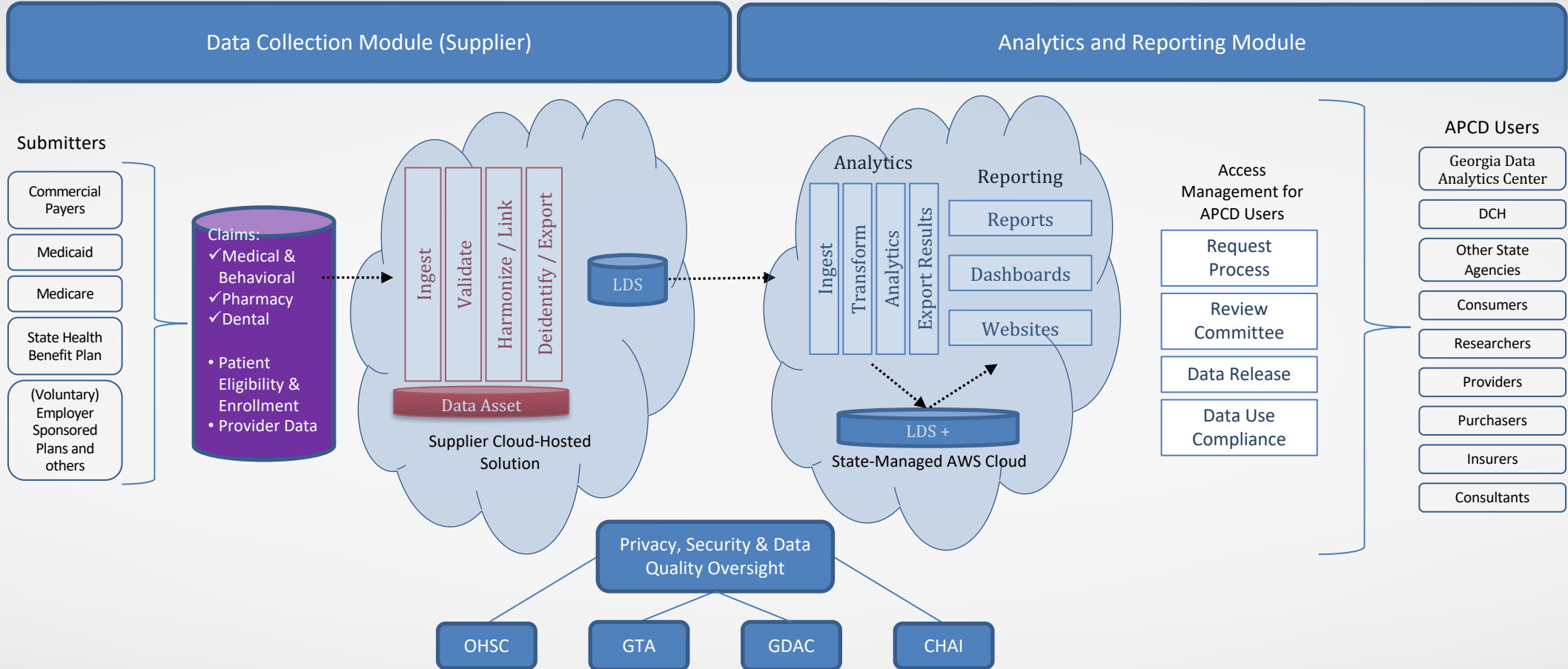

Selected Analytics Strategy

- OHSC, CHAI, GDAC, and GTA collectively developed an analytics strategy in November and December 2022
- At a high level, the strategy lays out the following responsibilities:
 - GDAC will own the analytics environment
 - CHAI will own delivery of the analytic use cases

- On track to have analytic environment complete by April 2023
- Can already accept data files from Onpoint

- Refining use cases into target outputs

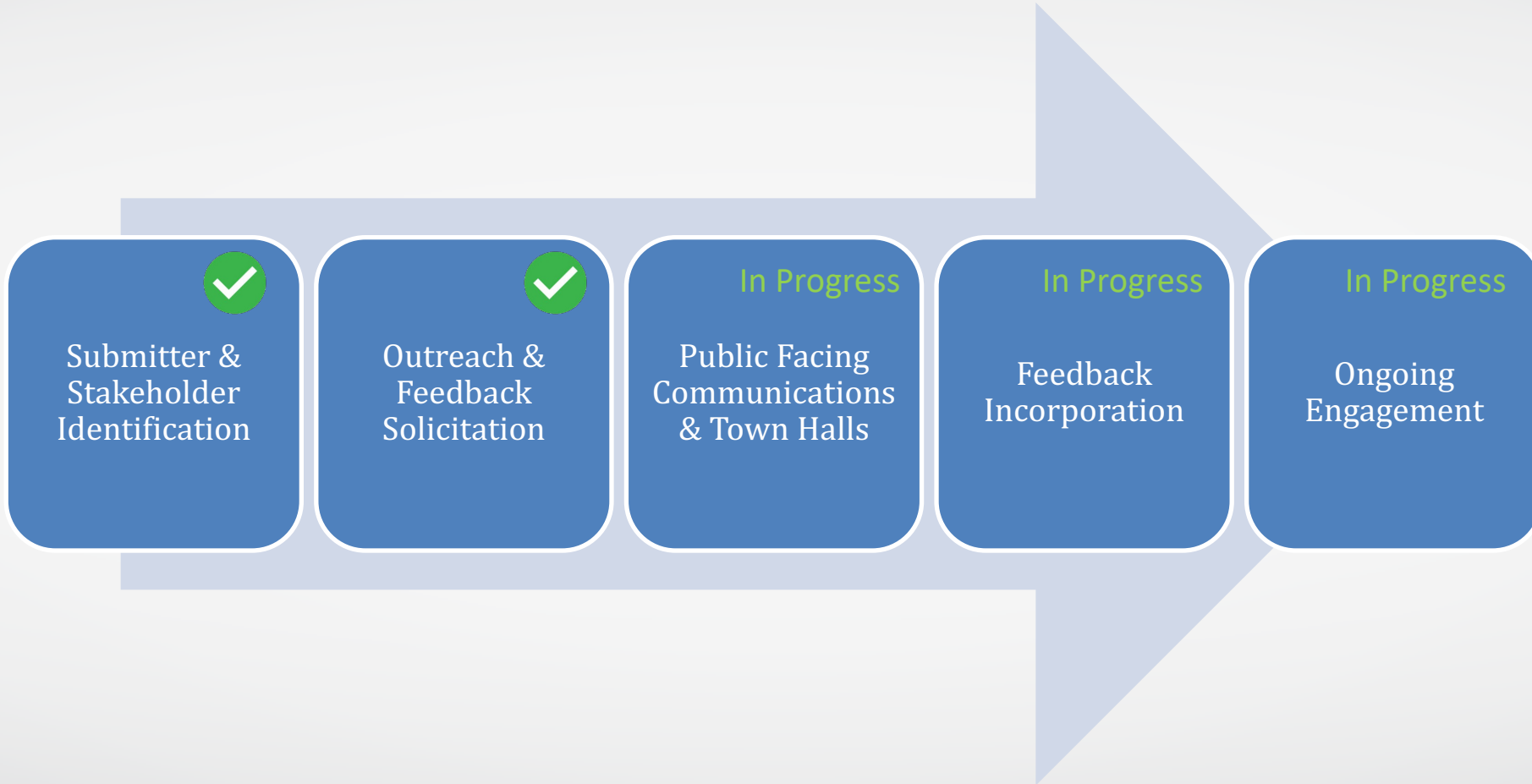
